Page 8 reflects the summary of activity in the State Investment Council's portfolio for the month ended February 28, 2017. Items to note:

- The Land Grant Permanent Fund received a Taylor Grazing Act distribution in the amount of \$84,079. The amount combined with the State Land Office contribution results in the total Land Grant Permanent Fund contributions of \$37,112,410.
- The monthly contribution from the State Land Office was \$37,028,331, a decrease of \$370,875 from January. For year-to-year comparison purposes, the February 2016 contribution from the State Land Office was \$35,644,966.
- The monthly beneficiary distributions of \$53,172,872 and \$16,703,527 from the permanent funds are reflected for Land Grant Permanent Fund (LGPF) and Severance Tax Permanent Fund (STPF), respectively.
- The January New Mexico Small Business Investment Corporation (NMSBIC) value of \$39,016,780 is reflected in the Severance Tax Permanent Fund's Small Business Investment Corp and miscellaneous loans amount.
- The second quarter management fee accruals are reflected in the fees column.
- The bimonthly transfers to the Administrative Fund from the Land Grant Permanent Fund and the Severance Tax Permanent Fund are reflected in the fees column as \$7,068,000 and \$2,232,000, respectively.
- Contributions, distributions and rebalancing by Third Party Clients are reflected on pages 14 thru 18. In December the following activity was processed:
  - Interstate Stream Commission contributed \$2,000,000 to their NM Unit Fund.
  - New Mexico Mortgage Finance Authority contributed \$133,062 to their IFT Housing Fund.
  - New Mexico Tech Research contributed \$100,000 to their Restricted Fund.

The total on page 11 reflects only the investment pools included on page 8 as a sub-total.

The total on page 13 is inclusive of the permanent funds and exclusive of the third party investors.
