Page 8 reflects the summary of activity in the State Investment Council's portfolio for the month ended January 31, 2017. Items to note:

- The monthly contribution from the State Land Office was \$37,399,206, an increase of \$2,987,839 from December. For year-to-year comparison purposes, the January 2016 contribution from the State Land Office was \$40,255,078.
- The monthly beneficiary distributions of \$53,172,872 and \$16,703,527 from the permanent funds are reflected for Land Grant Permanent Fund (LGPF) and Severance Tax Permanent Fund (STPF), respectively.
- The December New Mexico Small Business Investment Corporation (NMSBIC) value of \$38,953,987 is reflected in the Severance Tax Permanent Fund's Small Business Investment Corp and miscellaneous loans amount.
- The Tobacco Settlement Permanent Fund transferred \$109,052,359 to the General Fund to cover 2016 obligations per Laws 2016, 2nd Special Session, Chapter 2, Sec 2 A.
- Contributions, distributions and rebalancing by Third Party Clients are reflected on pages 15 thru 19. In December the following activity was processed:
 - New Mexico Retiree Health Care Authority contributed \$5,000,000.
 - New Mexico Commission of Public Lands withdrew \$2,700,000.
 - Interstate Stream Commission contributed \$5,000,000 to their NM Unit Fund.
 - New Mexico Mortgage Finance Authority withdrew \$1,310,374 from their IFT Housing Fund.
 - Clovis Community College rebalanced their Foundation fund.

The total on page 12 reflects only the investment pools included on page 8 as a sub-total.

The total on page 14 is inclusive of the permanent funds and exclusive of the third party investors.
