Page 8 reflects the summary of activity in the State Investment Council's portfolio for the month ended July 31, 2015. Items to note:

- The monthly contribution from the State Land Office was \$41,238,932; a decrease of \$1,342,128 from June. For year-to-year comparison purposes, the July 2014 contribution from the State Land Office was \$61,569,897.
- The monthly beneficiary distributions of \$54,648,764 and \$16,125,828 from the permanent funds are reflected for Land Grant Permanent Fund (LGPF) and Severance Tax Permanent Fund (STPF), respectively.
- The June 30, 2015 New Mexico Small Business Investment Corporation (NMSBIC) value of \$37,254,047.50 is reflected in the Severance Tax Permanent Fund's Economically Targeted Investments amount of \$37,273,317. This amount includes other loans that make up the balance.
- The annual \$4,000,000 distribution from the Water Permanent fund to New Mexico Finance Authority Public Projects Revolving Fund was processed on July 1st.
- Contributions, distributions and rebalancing by Third Party Clients are reflected on pages 14 thru 17. In July, New Mexico Military Institute Operating account contributed \$100,000. The Los Alamos County Permanent and Cemetery funds withdrew \$4,799,900 and \$200,000, respectively. The New Mexico Public Insurance Authority Benefits and Risk accounts re-balanced their accounts. New Mexico Mortgage Finance Authority – ITF Housing Trust withdrew \$272,545.

The total on page 11 reflects only the investment pools included on page 8 as a sub-total.

The total on page 13 is inclusive of the permanent funds and exclusive of the third party investors.
